Use in organic, transitional, or conventional crop production to promote greener looking plants and to correct or prevent nitrogen deficiencies. Suitable for use on all plant types as a foliar and soil fertilizer.

Grower's Secret Liquid Nitrogen 8-0-0 (GSN8) is a protein hydrolysate product that can be applied by ground or air applications or through irrigation. GSN8 is nontoxic to plants when applied as directed. For best results, apply GSN8 according to recommendations based on plant or soil analysis for a given crop.

MIXING INSTRUCTIONS: Mix well in the desired amount of water. GSN8 is believed to be compatible with most fertilizers, plant nutrients and pest control products. It is recommended that a physical compatibility test be conducted using small quantities in proportion to field application rates. Since lack of phytotoxicity on all crops has not been confirmed, test mixtures on a small portion of the field before wide spread application.

DIRECTIONS FOR USE:

Recommended rates are intended as a guideline only and may not be suitable for all regions, conditions, and crops. Specific application rates and timing should be determined from crop and soil analysis.

Agricultural and Horticultural Crops: Apply 1-5 quarts (0.95-4.7 L) per acre for soil applications and 1-2 quarts (0.95-1.9 L) per acre as a foliar application.

Lawn and Garden: Mix 1-3 fl. oz. (30-90 ml. of fertilizer) per gallon of water. Apply as a foliar spray, soil drench, or through irrigation systems every 2-4 weeks or as needed. For lawn and turf applications, do not apply near water, storm drains, or drainage ditches. Do not apply if heavy rain is expected. Apply only to the intended application site.
